EXTRACT FROM THE RULES

Article 1: The competition is open to all barristers, no matter what their nationality, mother tongue or age.

Article 4: Candidates must write a speech for the defence relating to a genuine, individual case of violation of human rights, taken from recent current affairs and proof of which must be provided and will be strictly required.

Article 5: The speech for the defence must be 5 (typed) pages long. It must be no longer than 10,200 characters (including spaces) or 1,700 words. The speech should last no longer than 15 minutes when spoken out loud.

Article 9: Speeches written in a foreign language will be translated into French. The Mémorial de Caen will cover all translation costs.

Article 16 : Candidates will be judged on the subject matter (a genuine, individual case), the strength of the arguments presented, how convincing their arguments are, their oratory talent and for respecting the allotted time.

Article 19: The Mémorial de Caen will arrange and pay for travel and accommodation for competition finalists (transport, meals and 3 nights in a hotel in Caen for finalists).
