The proposed Common European Sales Law - the lawyers' view

The proposal from the European Commission for a Regulation on a Common European Sales Law (CESL) has raised divergent reactions from various parties across Europe. In order to contribute actively to this discussion from the lawyers' point of view, the conference aims to promote a debate and exchange of views among legal practitioners regarding the main legal issues of the CESL. General questions such as 'Do we need a CESL?', 'Can the CESL achieve what it sets out to do?' and 'The relationship with Rome I and the Vienna Convention' will be addressed, as well as some specific provisions of the proposal. The conference will gather representatives from the European Commission and the European Parliament, and also lawyers from different jurisdictions across Europe known for their expertise in this field.
